Congratulations on taking a very important step towards improved health! You will be receiving a complimentary (no-charge) consultation to determine whether you may be a candidate for Neuro-Structural Integration (NSI) – a highly successful, non-invasive comprehensive approach for treating pain and restoring health and function. This system does not use medication or surgery.

Your first visit will take approximately 1 hour and fifteen minutes. Please dress in comfortable clothes – ladies pants (instead of dresses) are preferred but not required. Ladies and gentlemen, pants that can be rolled up slightly past the knee would be preferred. These steps will make it easier to conduct certain evaluations if required. Additionally, please **bring any applicable images (MRI's, CT's, and Films) and any associated written reports**. If you have difficulty locating or obtaining these, do not worry – we will help you with this after your consultation. If you have never had any images taken, you are still eligible for a consultation.


I also strongly recommend, if applicable and feasible, that you invite your partner or spouse to attend this consultation. Why? Great question. Often people who are closest to you can provide additional information that will better help us understand your case. Additionally, it has been my experience that partners and spouses who attend the evaluation process usually have a much better understanding of how to support their loved one's healing at home. Again, this is not a requirement but rather a strong recommendation based on what I have seen work time and time again for our patients. Please, do what is most comfortable for you.

After your consultation, we will study your case and your diagnostic images. On your second visit, also complimentary, we will take time to review all of this information with you so you have a full understanding of your injuries. At that time we will let you know if we can accept your case. **A few important, final points about your consultation.** First, not every patient is a good candidate for NSI. This means that, as much as we may want to help you, we may not be

able to accept your case. Regardless of the status of your acceptance, we will give you guidance on your next steps. Secondly, because we have only a limited number of times for consultations, if you cannot make your reserved appointment time (enclosed in this envelope), please call our office at least 24 to 48 hours in advance so we may give your reserved time to someone else in need. Thank you for this consideration.
